APTA Taste of South Africa Tour

September 30 – October 5, 2023

Day 1 – Sat. Sept. 30:

DEPART CAPE TOWN

Morning transfer to Cape Town International Airport for flight to Johannesburg. On arrival in Johannesburg, meet and assist by English-speaking guide and Vered Tours representative and transfer to hotel for check-in. Visit Constitution Hill, an important site in the history of the struggle for democracy and freedom in South Africa. Then return to the hotel for dinner and your overnight. **(D)**

Day 2 – Sun. Oct. 1:

SOWETO, JOHANNESBURG

Breakfast at hotel. Site Inspection of the Da Vinci Hotel before departure. Depart on a full day Soweto tour. Visit the Apartheid Museum, Hector Pietersen Museum and Mandela House. Lunch at a local restaurant in Soweto. After lunch, continue to Pretoria and visit the Mandela Statue at the Union Buildings and enjoy a drive-by city tour of Pretoria. Visit the Freedom Park Museum. Return to the hotel. Dinner and overnight at the Da Vinci Hotel. **(B,L,D)**

Day 3 – Mon. Oct. 2:

PILANESBERG NATIONAL PARK

Early breakfast at the hotel and check out. Depart hotel and transfer to Lesedi Cultural Village for Vuka (“Arise”) Show. After the show, transfer to the lodge in the Pilanesberg National Park. Lunch and check-in at the Bakubung Bush Lodge. Relax at the lodge then depart for an afternoon game drive. Return to the lodge for dinner and your overnight stay. **(B,L,D)**

Return to the lodge in the late afternoon. Relax until dinner. Dinner and overnight at Bakubung Game Lodge. **(B,L,D)**

Day 5 – Wed. Oct. 4:

JOHANNESBURG, O.R. TAMBO AIRPORT

Early morning game drive (game drive duration 3-4hrs depending on sightings incl. halfway stop for snacks and refreshments). Return to the lodge for breakfast at the lodge then check out. Depart for the Cradle of Humankind and visit Maropeng Museum. Transfer to Johannesburg airport with English-speaking guide for assistance. Departure flight back home in the evening. Lunch on your own. Shopping at mall or at craft market en-route to airport (if time permits)

Tour Terms & Conditions

Tour Price Inclusions: Economy-class flights from Cape Town to Johannesburg, all transfers and transportation in a modern, clean, AC-equipped motor coach, all hotel accommodations, meals as indicated, all touring and entrance fees as per the itinerary, the service of a full-time, licensed and experienced, English-speaking tour guide/manager, all gratuities to guide and driver.

Tour Price Exclusions: Drinks with dinners other than water (other drinks available on site at additional cost), any meals not mentioned in the itinerary, personal expenses such as laundry service and telephone calls, travel insurance, any items not included in "Tour Price Inclusions".

1. **PAYMENT:** Payment for the tour must be made directly by the passenger or by the travel advisor who is the passenger's agent for the collection and remittance of tour payments. No other person is authorized to request, receive or collect payments. NEVERTHELESS, VERED TOURS SHALL BE RESPONSIBLE ONLY FOR GOOD FUNDS PAID TO AND RECEIVED BY VERED TOURS. A deposit of \$200 per person is required at the time of booking. Balance of tour price must be received no later than **September 1, 2023** to confirm your reservations. Full payment received after **September 1, 2023** is subject to a \$50 late fee.
1. **CANCELLATION CHARGES:** No cancellation charges will be assessed prior to **June 30, 2023**, except for a \$75 administrative fee. Cancellations made after **June 30, 2023** will be assessed a \$200 penalty in addition to cancellation fees charged by the airlines, hotels or other service providers.
